## May Day Bank Holiday Weekend of Action, 4-6 May 2024

A big thank you to the organisers and supporters of all the events which took place across the country, and resulted in plenty of good conversations with the public about why the campaign is important. Several events were impacted by unscheduled stoppages, with the event at Shobnall Fields in Burton upon Trent run by the Swarkestone Boat Club only being confirmed at the last minute when Canal & River Trust managed to reopen a damaged bridge. The cruise of Rum'a'Gin to IWA Canalway Cavalcade was successfully completed but only after the need to change route several times to avoid further unplanned stoppages. <u>Good publicity</u> for the campaign was achieved by Rum'a'Gin's cruise, and the Telegraph picked up the <u>story</u> with the link being available to those who subscribe.

## Westminster Campaign Cruise, Wednesday 8 May 2024

The weekend of action culminated in a second Campaign Cruise past the Palace of Westminster on the tidal Thames during the lunchtime period on Wednesday 8 May 2024, when the Government received a wake-up call from inland waterways campaigners.

It was a spectacle for both the eyes and ears as the call to safeguard Britain's inland waterways reached the Palace of Westminster. A 20-strong flotilla delivered an unmistakable message to Government for funding to protect the future of our inland waterways. The boats came out of Limehouse at different times with a number setting off very early and passing through the Thames Barrier to mark the 40<sup>th</sup> anniversary of its opening by Queen Elizabeth II in 1984. After passing back through the barrier once it reopened after a scheduled test closure they met up with the other participating boats departing Limehouse.

The flotilla included a mix of commercial freight vessels, several sea kayaks and 17 privately owned narrowboats, some of which had travelled over 350 miles battling against the severe weather and failing canal infrastructure, determined to reach Westminster. United together, they sounded their horns to cheers from supporters on Westminster Bridge, capturing the attention of many MPs who had just attended Prime Minister's questions (see <u>here</u> for Wendy Morton MP's report and photo of the flotilla from the terrace). The boats made a very impressive sight and were given permission to hold station on the Thames within the exclusion zone outside the Palace of Westminster.

Welcoming the flotilla were crowds of inland waterway supporters and representatives from the campaign's alliance of organisations, including Dame Sheila Hancock DBE and Chair of the All-Party Parliamentary Group for the Waterways Sir Michael Fabricant MP, together with other dignitaries and FBW supporters onboard the MV Valulla. Speeches were made by Dame Sheila, Sir Michael, Chair of the Twentieth Century Society Hugh Pearman MBE and CEO of GPS Marine Holdings John Spencer.

Special thanks to Andrew and Frances Phasey for their detailed planning and organisation that ensured both the success of the cruise and the safety of all those involved. I must also thank London VTS, the Metropolitan Police, Canal & River Trust, the boaters, the VIPs, supporters on the bridge, supporters on social media and all who helped make it a successful event.
