

## Fund Britain's Waterways Update, November 2024

The need for investment was a highlight of the Chancellor's Budget but sadly no mention was made of the need for investment in our inland waterways. The good news was that no funding cuts were announced. FBW has issued a press release which you can read here.

On Wednesday 20 November between 10:30 and 13:00 we are holding a session with the Middle Level Commissioners (MLC) at which MLC Chief Executive Paul Burrows will answer questions submitted in advance by FBW members. The session will be online and FBW members will be able to watch on MS Teams by registering using this <u>link</u>. The questions will be available on the website shortly.

The social media push took place in early October and signatures on the petition are now over 53,000 but many more are still required. Tony Hales, former Chair of British Waterways and initial Chair of CRT, has produced a video for FBW which can be viewed <a href="https://example.com/here">here</a>. In the press release accompanying her final report as Waterways Ombudsman Sarah Daniel said

"The waterways are cherished by many and the passion for their upkeep is clear from complainants and the Trust alike. It is becoming apparent how difficult it is going to be for the Trust to maintain standards and services with dwindling resources and increasing demand and I wish them well in managing this."

The combination of Tony and Sarah's comments reinforces to me why a review of government funding for our inland waterways is so important.

With boater satisfaction at an all-time low with CRT, it is pleasing to see them starting to take measures to improve the maintenance situation starting with a programme to repair all the broken paddles. CRT had stopped publishing data on the number of unplanned navigation closure days after 2019/20. FBW is pleased that CRT has promised to resume publishing this data and also provided us with the missing data, which clearly illustrates why boater satisfaction has declined sharply.

FBW relies on volunteers to run the campaign, and we need more. Please see <u>volunteer vacancies</u>. In particular we want to sign up local authorities as FBW members. We need a volunteer to contact local authorities and ask them to join. Could this be you or somebody in your organisation?

Our volunteers will be active at Floodex and the Waterways Management Show at Excel in London on 27 and 28 November, promoting the campaign on stand C51 and also making presentations in the Waterways Theatre at 13:30 on the Wednesday and 11:30 on the Thursday.
